SUBJECT: Discuss Appointment and/or Removal of Board and Commission

Appointees

PREPARED BY: Angela Miller, City Secretary

BACKGROUND:

City ordinances state that Council shall make annual appointments to the City's boards and commissions no later than the second regularly scheduled Council meeting in September. Citizens interested in volunteering their time submit an application to the City Secretary's Office for consideration by the City Council.

Each appointment is for a term of two years, unless an individual is appointed to fill a vacancy. A "term year" shall be from October 1 until the following September 30. The terms shall expire on the 30th day of September of the second year. Citizens appointed by City Council are only allowed to serve four consecutive terms, with the exception of the board of directors for the Highland Village Community Development Corporation (4B). Per their Articles of Incorporation, no member shall serve more than three consecutive terms.

In the case of a vacancy, the Council shall appoint a replacement to fill an unexpired term. Council may consider appointing alternate members of said board to fulfill the vacancy prior to appointing new applicants.

Council enacted a mandatory attendance policy that requires a member of a board or commission not miss more than three consecutive meetings, and in no event shall he or she miss more than 25% of the regular meetings during a single term year. Council may consider declaration of vacancies on various boards and commissions in accordance with Code of Ordinances Section 2.04.037(a) based on appointee attendance records during the 2015-2016 term year.

IDENTIFIED NEEDS:

There are nineteen (19) positions with terms that expire on September 30, 2016. This includes six (6) positions that have/or will soon have a vacancy.

Following is a listing of all currently serving members of each board and commission, including their history of service and the expiration date for their current term. The highlighted positions have terms that will expire in 2016.

OPTIONS & RESULTS:

Council to discuss making appointments and/or removal of appointees on the Board of Ethics, Highland Village Community Development Corporation (4B), Parks and Recreation Advisory Board, Planning and Zoning Commission, Public Art Advisory Board, and Zoning Board of Adjustment.

PROGRESS TO DATE:

A call for volunteers was advertised in the June, July and August utility bill inserts, the Summer Villager Newsletter, the City's Facebook Page, HVTV News, and on the City's website. To date, the City Secretary has received a total of thirty-one (31) applications, which include currently serving members who wish to be considered for reappointment to the same or a different position.

Members who are currently serving on Boards and Commissions with terms expiring on September 30, 2016 were contacted and given the opportunity to notify the City Secretary's Office if they were interested in being considered for reappointment.

- Nine (9) members wish to be considered for reappointed to the same Board or Commission.
- Four (4) members wish to be considered for appointed to a different Board or Commission.

In addition seventeen (17) new applications were received by the City Secretary for consideration by Council.

Council was provided with copies of all applications received by the City Secretary for their review and consideration during the early worksession at the August 23, 2016 Council Meeting. Attendance records for the various boards and commissions were also provided to Council at that time. Council hosted a "Meet and Greet" event on September 13, 2016 to allow an opportunity for applicants and Council to visit.

COMMENTS

Mayor Wilcox and City Manager Michael Leavitt attended a Legislative Strategy Meeting on September 29, 2016. With the upcoming 85th Legislative Session being held in 2017, elected officials, city staff from eleven area cities, and county officials were invited to attend the round table discussion to identify areas of common concern. A representative from TML Legislative Services presented information regarding the upcoming Legislative Session.

A copy of the City of Highland Village 2015 State Legislative Program is included with this briefing for reference purposes.

City staff will provide highlights of the Legislative Strategy Meeting.

City of Highland Village 2015 State Legislative Program



CITY OF HIGHLAND VILLAGE 2015 LEGISLATIVE POLICY STATEMENT

The Highland Village City Council desires to express their appreciation for the dedication of legislators serving Highland Village and the Denton County community. Because we serve and share the same constituents, we desire to partner with you for the betterment of our citizens and community.

We have prepared a list of concerns and issues impacting the City of Highland Village that are likely to be addressed during the 2015 legislative session. Many of these items are frequent annual concerns – their redundancy speaks to their continuing importance and not our lack of creativity. We will be particularly concerned about unfunded mandates and attempts to erode our local authority to determine local spending and taxing priorities.

Local Taxing & Spending Decisions Should Be Made By Locally Elected Officials

The Highland Village City Council strongly opposes the enactment of state imposed spending or taxation controls or lids. The proposals create an arbitrary and capricious procedure for what should be an essential function of representative democracy: elected officials determining the appropriate spending and taxing policies of their community. Local tax and spending decisions should be made by locally elected officials – not by artificial limits in the state's statutes or constitution. We support the current law which requires truth in taxation and allows a rollback election if the rollback rate is exceeded.

Priority:

Oppose legislation that would negatively expand appraisal caps, impose a revenue cap of any type, including a reduced rollback rate, mandatory tax rate ratification elections, lowered rollback petition requirements, limitations on overall city expenditures, exclusion of the new property adjustment in effective rate and rollback rate calculations.

Unfunded Mandates

The City of Highland Village opposes unfunded mandates from the State of Texas. These mandates drain limited resources from needed City programs and activities. State legislators know how federal mandates hamper the state's ability to respond to problems and issues. Similarly, the state should not impose unfunded mandates on local units of government.

Priority:

Oppose any bill that would redirect, reduce or reapportion municipal revenues, whether from taxes or fees for service, collected by cities that would fund a State or Federal mandate.

Oppose additional state fees or costs on municipal court convictions or the requirement that municipal courts collect fine revenue for the state.



Transportation Planning and Funding

We support transportation funding options for the highway infrastructure in Texas such as a motor vehicle sales tax, additional vehicle registration fees, a local option gas tax, or a new resident impact fee. We are committed to supporting regional efforts to address the mobility and air quality needs of our citizens now and in the future. Maintaining the aging highway infrastructure throughout Texas and expanding the highway system for statewide connectivity and maintaining urban mobility requires far greater investment in transportation infrastructure than is possible with current transportation revenues. We support the initiatives of the Denton County Transportation Authority "DCTA" to advance the development and funding of regional rail throughout the North Texas region.

Priority:

We support the discontinuation of the diversion of transportation revenues to non-transportation purposes and support appropriate revenues from highway user fees and taxes to fund transportation.

We support providing additional funding to the Texas Department of Transportation for transportation projects that would benefit cities, so long as existing funding formulas are followed.

We support providing the funding for phase II of the reconstruction of the Interstate 35Express project.

State Limits on Land Use & Related Activities

We oppose efforts to unnecessarily restrict the City's current authority to exercise eminent domain powers for public purposes and regulations that limit City's ability to maintain property values. Public infrastructure and community improvements sometimes require the condemnation of private property interests — these important powers should not be unnecessarily reduced.

Priority:

We support legislation that would enhance the ability of cities to enforce local ordinances intended to protect the health, public safety, and quality of life of local citizens.

Right-of-Way

Highland Village's ability to franchise utility companies and regulate its public rights-of-way must not be compromised. Private companies which use a public asset – such as locally owned right-of-way – should continue to be required to collect franchise fees for the use of public right-of-way and property. These utilities should also continue to be required to relocate in the right-of-way for public projects at their own expense – and not at the expense of local taxpayers.

Priority:

Oppose any bill that would decrease the authority of a city to be adequately compensated for the use of its rights-of-way and that would erode municipal authority over the management and control of rights-of-way.



Ensuring Adequate Water Supplies for Our Future

Because a good water supply is essential to the welfare and growth of the Highland Village community, the City Council has taken steps to assure continued quality water resources. The City opposes federal and state regulatory changes to quality standards that are not demonstrably related to public health unless adequate state and federal financial assistance is provided to meet such new treatment requirements. We oppose water transfers that will negatively affect Highland Village's current and future water supplies.

Priority:

Oppose any bill that would impose state "tap fees" or any other type of state

charge on municipal water systems.

Oppose state mandate on water conservation measures.

The Highland Village City Council supports local controls of ground water

resources for domestic water use only.

Public Safety - Homeland Security

The City of Highland Village urges an active partnership between state and local governments regarding issues of Homeland Security. The City's police department and our City/County fire and emergency medical services department are essential resources in providing security and safety to our community. These departments rely on funding resources that should be protected by our State legislature.

Priority:

We support amending the Water Safety Act (Chapter 31 of the Texas Parks and Wildlife Code) to allow municipal courts to retain portion of a fine under that chapter.



General Legislative Priorities

Allow a city the option of selecting either an official newspaper or an official Web site for the publication of official notes required by law.

Exempt candidate forums from the definition of a "meeting" in the Texas Open Meetings Act.

Oppose any bill that would eliminate any of the current uniform election dates.

Oppose the establishment of model rules relating to municipal regulation of gas wells, gas pipelines, or other gas-related equipment, unless the legislation or rules apply to only county regulation in the unincorporated area of the county.

Increase future local parks funding.

Oppose any bill that would lengthen or broaden the scope of the current sales tax holiday.

Oppose any bill that would expand election requirements for issuance of any city debt or that would impose a petition/election procedure where none currently exists.

Enhance the penalty for hacking into a government-owned computer.

Oppose any bill that would erode existing municipal authority relating to sex offender residency restrictions, or create a state standard that preempts current or future municipal sex offender residency restrictions.

Oppose any bill that would erode municipal authority to require utility companies to pay the costs of relocating their facilities in a timely manner as required by current law.

Oppose any bill that would limit city authority over employee benefits.

Oppose any bill that would, whether at the state or federal level, make "meet and confer" mandatory or expand the current "meet and confer" law.

Oppose any bill that would, whether at the state or federal level, make collective bargaining mandatory or impose expanded collective bargaining rights.

Create a new council-option city sales tax for property tax relief that may exceed the twopercent local cap.

Expand the use of public, educational, and government (PEG) fees to include operational and related costs associated with PEG channels.

The following people spoke:

Edgar Meador (3087 Whispering Oaks) – Mr. Meador said he recently moved to Highland Village from Coppell and is concerned about the Public Storage building; he stated the large orange stripe is distracting to the community; asked if the City can possibly contact Public Storage to see if they can reduce the size of the orange stripe

Rick Stiggers (707 Windsor Court) – Mr. Stiggers said he moved to Highland Village almost a decade ago; he stated the Public Storage building looks totally out of place and that it makes no sense to put up a commercial building in the beautiful neighborhood and feels Council owes the community an explanation

Lon Baugh (801 Tree Haven Court) – Mr. Baugh said he has lived here since 2007 and he loves the neighborhood, community and public services in Highland Village; stated he became aware of the Public Storage project last year and had initial thoughts about good land use but increased traffic; he reported he became more concerned as he saw the building height, mass, and minimal set back, which seemed unusual for that area; he voiced concern about the size and orange color of the stripe along the top of the building and the impact on neighboring residences from night time lighting of the development; suggested leaving the orange street level sign and to use better judgment in the future.

Scott Martin (774 Lakewood Court) – Mr. Martin moved here six years ago from California; he stated he loves Highland Village and is a huge advocate; he reported when he saw the construction fencing for the project, he thought it would make a great place for a dog park, but when he saw the Public Storage sign go up he couldn't understand how a commercial building could be located there in a residential neighborhood; he further stated there is now a massive three story building located right in people's back yards; he is asking the City for help in getting the orange stripe changed to something that will blend in better

Jenny Banks (3030 Lakeside Drive) – Ms. Banks moved to Highland Village three years ago; she stated she is extremely proud of our Police and Fire Departments; she stated one thing she likes about the City is the precedence that has been established regarding construction standards in Highland Village; she voiced she is disappointed and discouraged about the Public Storage building and that she dittos what has been said by the other speakers; right now the orange stripe is the primary concern at this point because that is the thing that can be changed; she is curious if there can be a conversation so that everyone wins; she is hoping for common sense solutions

Teri and Don Cowan (3091 Whispering Oaks) – Mr. Cowan reiterated the orange stripe and lighting are their major concerns; he feels it sticks out like a sore thumb; Ms. Cowan stated they moved to Highland Village from Dallas and doesn't think residents were aware of the earlier meetings regarding the project; Ms. Cowan stated they are disappointed in the Public Storage building

The following people did not wish to speak but were in opposition:

Natalie Schock (3035 Woodhollow) – concerned about the orange stripe, lighting, and crime due to the hours of operation

John Schock (3035 Woodhollow)

Suzanne Ranson (3103 Whispering Oaks) – concerned about the orange strips, lighting and increased crime

APPROVED 2nd READ

Assistant City Manager Ken Heerman reported City staff initiated the FY 2016-2017 Budget process in May of this year with departments reviewing programs and related costs in their respective areas. The budget was developed with Council in a series of workshops: the Capital Improvement Program was presented, followed by the General Fund Budget, Special Revenue Funds, and the Utility Fund. The proposed budget has been available on the City Web Site for review by residents. The final document presented is a joint product of staff and Council to reflect priorities established by Council in the initial stages of this budget process. He stated the FY 2016-2017 Budget is presented for Council approval, and that the presented budget mirrors the expressed consensus of Council from the budget work sessions.

He further reported Truth in Taxation, specifically Local Government Code Section 102.007, requires specific action in adoption of the budget, and a vote to adopt the budget must be a record vote. Mr. Heerman stated the adopted budget must contain a cover page that includes a number of specifically worded statements regarding revenue, delineation of the record vote to adopt the budget, tax rates, and debt obligations amounts. All the pertinent information is likewise included in the City Manager Recommended Budget posted on-line, save the record vote of council – which will be updated subsequent to the actual council vote.

Mr. Heerman stated additionally, adoption of a budget that will require raising more revenue from property taxes than in the previous year requires a separate vote of council to ratify the property tax increase reflected in the budget. As this budget does indeed raise more revenue, this is to be presented next as a separate companion agenda item with this 2^{nd} read.

Motion by Councilmember McGee, seconded by Deputy Mayor Pro Tem Meek, to approve the second read of Ordinance 2016-1215 adopting the Fiscal Year 2016-2017 Annual Budget.

City Secretary Angela Miller took a roll call vote on the motion:

19. Consider Resolution 2016-2660 Ratifying the Property Tax Revenue Increase Reflected in the 2016-2017 Fiscal Year Budget APPROVED

Mr. Heerman reported in accordance with Local Government Code §102.007(c), adoption of a budget that will require raising more revenue from property taxes than in the previous year requires a separate vote of Council to ratify the property tax increase reflected in the budget. This action acknowledges that Council is aware this budget will cost more than last year's budget. As this budget does indeed raise more revenue, this

is required action. Although the property tax rate is unchanged from last year, overall tax dollars are increased – this year collecting \$11,483,760 compared to \$10,943,987 last year.

Motion by Mayor Pro Tem Schwolert, seconded by Councilmember Busche, to approve Resolution 2016-2660 ratifying the property tax revenue reflected in the Fiscal Year 2016-2017 Budget. Motion carried 7-0.

20. Consider Ordinance 2016-1216 Levying the Ad Valorem Taxes for the Year 2016 at a Rate of \$0.56963 per \$100 Assessed Valuation on all Taxable Property within the Corporate Limits of the City of Highland Village as of January 1, 2016 (2nd and final read)

APPROVED 2nd READ

Mr. Heerman reported Texas Tax Code §26.05 requires a tax rate be adopted by official action following passage of a budget. He stated the proposed tax rate of \$.56963/\$100 is unchanged from last year, and has remained the same since 2000.

Pursuant to the direction of the City Council, the City Manager has prepared the FY 2016-2017 budget based on anticipated revenues to the City from various sources, including the assessment of taxes on real and business personal property located within the City. Because the proposed tax rate will exceed the effective tax rate of \$0.55058 per \$100 valuation (which is the rate that would provide the same amount of funds raised from property taxes for the current fiscal year), state law requires the governing body must vote by a record vote.

Motion by Councilmember Busche,, seconded by Councilmember Fleming, that the property tax rate be increased by the adoption of a tax rate of \$.56963, which is effectively a 3 percent increase in the tax rate and, therefore, further move that Ordinance No. 2016-1216 be approved on second reading.

BACKGROUND:

In our original annexation, the City of Highland Village Eastern Corporate limits were established as the west edge of the Interstate 35E right-of-way in the area of Copperas Branch Park. The 35Express Project has encroached approximately 450 feet west of the existing established right-of-way to provide the needed expansion of the I-35 project.

The City of Lewisville has historically provided Police, Fire, and EMS for the I-35E corridor within its corporate limits, including the portion of I-35E that establishes the eastern limits of the City of Highland Village. As the result of the expansion of I-35E to the west, in order to maintain the historical enforcement of traffic laws and other matters along the I-35 Corridor, it will be necessary to adjust the boundaries of the two cities so that the new westerly right-of-way for Interstate 35E is located within Lewisville.

A secondary aspect of the proposed boundary adjustment agreement relates to Copperas Branch Pond (Pond), South of Highland Village Road. Currently the Pond is split between Highland Village (on the west side) and Lewisville (on the east side). It is proposed that Highland Village annex the entire Pond area up to Lewisville's corporate limit line, which will be established as the Northwest property line of the Highland Lakes Phase II, Final Plat for the City of Lewisville. The annexation does include the shoreline of the Pond. The shoreline and pond area is currently not under any lease by either city from the Corp of Engineers. The Corp of Engineers and the City of Highland Village are currently working on the development of a lease agreement which will be similar to our lease for Wichita Forrest. Both areas are zoned Wildlife Management which allows only passive recreation activities only.

The first public hearing was held on Tuesday, September 13, 2016, and the second was held on Wednesday, September 14, 2016.

IDENTIFIED NEED/S:

Tonight is the first read of proposed Ordinance 2016-1218 annexing the area within and adjacent to the Pond to Highland Village and disannexing.

OPTIONS & RESULTS:

PROGRESS TO DATE: (if appropriate)

Highland Village and Lewisville have negotiated a boundary agreement with the City of Lewisville accordingly.

BUDGETARY IMPACT/ORDINANCE CHANGE: (if appropriate)

There is no value gained or lost by either City, all area being swapped in this boundary adjustment is owned by the U.S. Federal Government or by the State of Texas as right-of-way, which provides no property tax value to the cities.

RECOMMENDATION:

AN ORDINANCE OF THE CITY OF HIGHLAND VILLAGE, TEXAS, MODIFYING ITS CORPORATE BOUNDARIES IN ACCORDANCE WITH A CERTAIN BOUNDARY ADJUSTMENT AGREEMENT ENTERED INTO WITH THE CITY OF LEWISVILLE; FINDING THAT ALL NECESSARY AND REQUIRED LEGAL CONDITIONS HAVE BEEN SATISFIED; PROVIDING THAT SUCH AREA AS DESCRIBED IN EXHIBIT "B" OF SAID BOUNDARY AGREEMENT SHALL BECOME A PART OF HIGHLAND VILLAGE AND THAT THE OWNERS AND INHABITANTS THEREOF SHALL BE ENTITLED TO THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BE BOUND BY THE ACTS AND ORDINANCES NOW IN EFFECT AND TO BE HEREINAFTER ADOPTED; PROVIDING THAT SUCH OTHER AREA DESCRIBED IN EXHIBIT "A" OF SAID BOUNDARY AGREEMENT SHALL BE RELEASED UNTO THE CITY OF LEWISVILLE FOR INCLUSION WITHIN ITS CORPORATE LIMITS; APPROVING A SERVICE PLAN; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City Council of the City of Highland Village, Texas (the "City"), pursuant to the Municipal Annexation Act, Texas Local Government Code, §43.001 et seq., as amended, and Sections 1.04 and 1.05 of the Highland Village City Charter, desires to adjust its corporate boundaries in accordance with a certain Boundary Adjustment Agreement between the City and the City of Lewisville (the "Agreement"), as described in Attachment "1"; and

WHEREAS, the City is a duly constituted Home Rule City pursuant to Article XI, Section 5 of the Texas Constitution, as amended: and

WHEREAS, two separate public hearings were conducted in accordance with Section 43.063 of the Municipal Annexation Act, the first being held at 7:30 p.m. on the 13th day of September, 2016, at the City Council Chambers, 1000 Highland Village Road, Highland Village, Texas; and the second hearing being held at 12:00 p.m. on the 14th day of September, 2016, at the City Council Chambers, 1000 Highland Village Road, Highland Village, Texas; and

WHEREAS, the public hearings were conducted and held no more than forty (40) days nor less than twenty (20) days prior to the institution of these proceedings; and

WHEREAS, notice of the public hearings was published in a newspaper of general circulation in the City and in the area described in the Agreement, at least once in said newspaper not more than twenty (20) days nor less than ten (10) days prior to each public hearing; and

WHEREAS, notice of the public hearings was also posted on the City's internet website on or after the 20th day but before the 10th day before the date of the public hearings and remained posted until the date of the public hearings; and

WHEREAS, a service plan for the area brought into the City's corporate limits was made available for public inspection and explained at the public hearings.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HIGHLAND VILLAGE, TEXAS, THAT:

- **SECTION 1.** The Agreement, attached hereto as Attachment "1" and made a part hereof for all purposes, is hereby adopted.
- **SECTION 2.** The property described in Exhibit "B" of Attachment "1" shall be and is hereby annexed and brought within the corporate limits of the City of Highland Village, Texas, and same is hereby made an integral part hereof.
- **SECTION 3.** The property described in Exhibit "A" of Attachment "1" shall be and is hereby disannexed and released unto the City of Lewisville, Texas, for inclusion within the corporate limits of the City of Lewisville, Texas.
 - **SECTION 4**. The service plan attached as Exhibit "C" of Attachment "1" is approved.
- **SECTION 5.** The owners and inhabitants of the property described in Exhibit "B" of Attachment "1" shall be entitled to all of the rights and privileges of other citizens and property owners of the City and are hereby bound by all acts, ordinances and all other legal action now in full force and effect and all those which may be hereafter adopted.
- **SECTION 6.** The official map and boundaries of the City, heretofore adopted and amended be and is hereby amended so as to reflect the boundary adjustments described in the Agreement.
- **SECTION 7.** The City Manager is hereby directed and authorized to perform or cause to be performed all acts necessary to correct the official map of the City to reflect the boundary adjustments described in the Agreement, as required by law.
- **SECTION 8.** The City Secretary is hereby authorized to send a certified copy of this ordinance to the Office of the County Clerk of Denton County, Texas.
- **SECTION 9.** If any section, subsection, sentence, phrase, or word of this ordinance be found to be illegal, invalid or unconstitutional, or if any portion of said property is incapable of being annexed by the City, for any reason whatsoever, the adjudication shall not affect any other section, sentence, phrase, word, paragraph or provision of this ordinance or the application of any other section, sentence, phrase, word, paragraph or provision of any other ordinance of the City. The City Council declares that it would have adopted the valid portions and the applications of this ordinance and would have annexed the valid property without the invalid part, and to this end the provisions of this ordinance are declared severable.
- **SECTION 10.** Every ordinance or parts of ordinances found to be in conflict herewith are hereby repealed.
- **SECTION 11.** This Ordinance shall take on the effect on the later of (i) the date of its passage on Second Reading and publication of the caption in accordance with the provisions of the Charter of the City of Highland Village, and it is accordingly so ordained and (ii) the effective date of a like ordinance approved by the City Council of the City of Lewisville, Texas, releasing and disannexing from its corporate limits the property described in Exhibit "B" to Attachment "1" hereto and annexing and incorporating into the corporate limits of the City of Lewisville, Texas, the property described in Exhibit "A" to Attachment "1" hereto.

§ BOUNDARY ADJUSTMENT AGREEMENT

COUNTY OF DENTON §

This **Boundary Adjustment Agreement** ("Agreement") is made by and between the **City of Highland Village** ("Highland Village") and the **City of Lewisville** ("Lewisville"), both being Texas home rule municipalities (collectively referred to as "Cities"), acting by and through their authorized representatives.

Recitals:

WHEREAS, a portion of Highland Village's eastern boundary is located along the western boundary of the existing southbound lanes of Interstate 35E ("I-35E"), which boundary is also contiguous to the boundary line of Lewisville's incorporated limits; and

WHEREAS, the new southbound I-35E bridge over Lewisville Lake is being constructed within Highland Village's incorporated limits; and

WHEREAS, absent some adjustment in the boundaries of the Cities along the I-35E corridor, Highland Village will have traffic enforcement jurisdiction on the new southbound lanes of I-35E while Lewisville has traffic enforcement jurisdiction on what will become only northbound lanes of I-35E; and

WHEREAS, the Cities desire to modify their mutual boundary so that Lewisville will have primary traffic enforcement jurisdiction of all lanes of I-35E upon completion of construction of the new southbound lanes; and

WHEREAS, part of the I-35E project includes construction of a bike and pedestrian trail bridge ("the Trail Bridge") across the body of water located on the south of Highland Village Road and west of I-35E commonly known as "Copperas Lake" which will connect to Highland Village's existing public trail system; and

WHEREAS, the incorporated limits of the Cities presently bisect Copperas Lake; and

WHEREAS, the Texas Department of Transportation ("TxDOT") has expressed a desire that the Trail Bridge be located within the jurisdiction of only one of the Cities in order to facilitate future maintenance of the Trail Bridge when construction is completed; and

WHEREAS, the Cities desire to modify their mutual boundary so that the entirety of Copperas Lake is located within Highland Village's incorporated limits; and

WHEREAS, all of the land affected by the boundary adjustments described above is uninhabited and owned by either the United States of America or the State of Texas such that there will be no impact on residents of either City nor any loss of ad valorem or sales tax base by either City; and

WHEREAS, the Cities desire to enter into an agreement providing for the adjustment of their boundaries pursuant to Tex. Loc. Govt. Code §43.031, as amended; and

WHEREAS, the boundary adjustment proposed by this Agreement is exempt from the requirements of Tex. Loc. Govt. Code §43.052; and

NOW THEREFORE, in exchange for the mutual covenants set forth herein and other valuable consideration, the sufficiency and receipt of which are hereby acknowledged, the Cities agree as follows:

Article I Statement of Intent

It is the intent of the Cities to modify their respective boundaries in accordance with this Agreement.

Article II Release of Territory

To accomplish the objective set forth in Article I:

- (a) Highland Village hereby grants, releases, and apportions unto Lewisville for inclusion within Lewisville's incorporated limits the property which is more particularly described and identified in Exhibit "A" attached hereto and incorporated herein by reference ("the I-35E Tract").
- (b) Lewisville hereby grants, releases, and apportions unto Highland Village for inclusion within Highland Village's incorporated limits the property which is more particularly described and identified in Exhibit "B" attached hereto and incorporated herein by reference ("the Copperas Lake Tract").

Article III Waiver of Extraterritorial Jurisdiction

- (a) Highland Village does hereby waive all of its extraterritorial jurisdiction rights, if any, existing by reason of the I-35E Tract in favor of Lewisville. It is expressly agreed and understood that this waiver shall operate only in favor of Lewisville, and shall not constitute a waiver of any right, including extraterritorial jurisdiction rights, which Highland Village may be able to assert against any other municipality.
- (b) Lewisville does hereby waive all of its extraterritorial jurisdiction rights, if any, existing by reason of the Copperas Lake Tract in favor of Highland Village. It is expressly agreed and understood that this waiver shall operate only in favor of Highland Village, and shall not constitute a waiver of any right, including extraterritorial jurisdiction rights, which Lewisville may be able to assert against any other municipality.

Article IV Service Plans

- (a) Upon ratification and adoption of this Agreement by an ordinance adopted by the City Council of the City of Highland Village, Highland Village does hereby agree to immediately begin implementation into the affected area of the service plan attached hereto and made a part of this Agreement as Exhibit "C" with respect to the Copperas Lake Tract.
- (b) Upon ratification and adoption of this Agreement by an ordinance adopted by the City Council of the City of Lewisville, Lewisville does hereby agree to immediately begin implementation into the affected area of the service plan attached hereto and made a part of this Agreement as Exhibit "D" with respect to the I-35E Tract.

Article V Severability

Should any provision of this Agreement be declared void by a court of competent jurisdiction, the remaining provisions of this Agreement shall remain in full force and effect.

Article VI Effective Date

The Cities agree that the boundary adjustment set forth in this Agreement shall take effect only upon ratification and adoption by the governing bodies of each City.




