#### EARLY WORK SESSION

#### 1. Review and Discuss City Council's Goal and Objectives

City Manager Michael Leavitt stated in prior years, the City Council developed goals and objectives which serve as a work plan to direct city staff in meeting the challenges and opportunities of Highland Village. He stated the City's mission statement, organizational values, and Council's goals and objectives are all used as a guide in providing relevant services and programs for our residents and business community, and are further used for long-term planning during our annual budget process.

Mr. Leavitt stated in reviewing the Council goals and mission statement, they are very similar, and therefore Council could eliminate the goal and focus on the mission statement. Mr. Leavitt stated this would be a good time to review and possibly update prior to beginning on next year's fiscal year budget. He stated he did not think there would be a lot of major changes, but possibly an opportunity to hold a planning session during the summer to modify. As the City is close to substantial build-out, Council also discussed shifting some focus to more of a maintenance mode. Assistant City Manager Ken Heerman stated the emphasis on long-term fiscal sustainability has dictated close scrutiny on expenditures for services and supplies. Each year this is evaluated in context of maintaining the current level of funding, however, with an overall goal for increases to not

exceed inflation. Programs and expenditures are evaluated in context of need and the ability to fund.

Mr. Leavitt reported City staff would also review the initiatives for each department and asked Council to review and forward any comments to him. He suggested holding a planning session in early summer to complete the updates.

# 2. Clarification of Consent or Action Items listed on today's City Council Regular Meeting Agenda of April 10, 2018

Relating to Agenda Item #16, Mr. Leavitt reported action on this item would be postponed until the next meeting as the contract is still being reviewed by the City Attorney. He stated representatives from CWD would be present at tonight's regular meeting to introduce the company and answer any questions Council may have. Councilmember Jaworski asked about the holiday schedule for trash pickup. Mr. Leavitt reported there would be no service on Thanksgiving or Christmas days. For homes scheduled for pick up on those days, the collection would be delayed by one day. Deputy Mayor Pro Tem Fleming asked if there were any penalties included in the contract. Mr. Leavitt reported the current contract with Waste Management did not include any, however, liquidated damages have been included in the new contract.

# **BACKGROUND:**

The current solid waste collections contract expires August 31, 2018. Council received a presentation from the consultant, Solid Waste Specialists, LLC, during the March 27<sup>th</sup> meeting recommending Community Waste Disposal L.P. to provide for solid waste and recycling collection services for the City. Staff has drafted an agreement for the services which at the time of the preparation of this briefing is under review by CWD, which agreement still requires review of the City Council and City Attorney. Staff is working to have the draft agreement available to City Council in sufficient time to allow for review and comment before the April 24<sup>th</sup> council meeting. The proposed agreement will provide for an initial term of five years and require CWD provide the following solid waste, recycling, and household hazardous waste collection services:

- Continuation of 10 bags per week of garbage collected once per week
- Increase the recycling cart size to 95 gallons upon request or keep the existing recycle cart
- Provides for collection of 1 cu yd of recycling outside of the recycle cart
- Continues the collection of compost materials on the same Monday collection schedule
- Provides for the collection of large brush and bulky items twice monthly without the need for the resident to call in; volume of each collection will be 2 cubic yards (6' X 3' X 3', or roughly the size of a refrigerator
- Provides for resident-delivered materials at the firm's facility
- Provides a solution for above-the-limit brush and bulky collections that can be assessed a reasonable fee
- Continues the provision of household hazardous waste at the curb

Staff is seeking Council comments regarding the draft agreement to be provided.

Below is a timeline of the project: October 24, 2017 – hired consultant December 2017 - the RFP was advertised January 17, 2018 - a mandatory Pre-Proposal meeting was held February 14, 2018 - proposals were accepted March 10, 2018 – met with CWD to discuss its proposal March 24, 2018 – presented recommendation to Council April 10, 2018 – presentation by CWD

#### RESOLUTION NO. 2018-2743

#### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HIGHLAND VILLAGE, TEXAS AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH COMMUNITY WASTE DISPOSAL L.P. TO PROVIDE SOLID WASTE AND RECYCLING COLLECTION SERVICES FOR THE CITY OF HIGHLAND VILLAGE, AND PROVIDING AN EFFECTIVE DATE

**WHEREAS,** City administration has obtained a proposal from Community Waste Disposal, L.P. for solid waste and recycling collection services, and recommends negotiation and execution of an agreement for such services; and

**WHEREAS**, City Administration and consultant recommends contracting with Community Waste Disposal to perform the desired services; and

**WHEREAS,** the City Council of the City of Highland Village, Texas, finds it to be in the public interest to accept the recommendation of the City administration.
